Dear Mr. President,

I submit to you the draft agenda of the 4th WKC Congress on 11th June 2009 in Ft. Lauderdale, Florida, USA.

Any suggestions for inclusion to the agenda or discussion on the congress must be submitted to my office until 30^{th} April 2009 in order to send out the final agenda to all members 30 days prior to the congress.

All persons wishing to run for a position in the Executive Committee or as an Auditor must submit their candidature also to my office by the 30^{th} April 2009. Each candidate shall attach a short CV (full name, age, profession, name of federation, rank in karate and a photo). Each candidate must submit a written, signed and stamped letter of support from his federation.

I will attach the list of candidates and their CV with the final agenda.

I propose two amendments of the WKC Statutes, Art. 5.1 and Art. 5.8 e):

a) the Founding President of the WKC should be a permanent member of the Executive Committee. Everybody knows our Founding President who has lead the WKC in the first nine years so successfully and still is very much involved in major issues of our confederation.

b) Art. 5 speaks of the *Vice-Presidents*, but Art. 4.8 e) speaks of *members*. This should be clarified.

Amendments of the Statutes

Art. 5 - EXECUTIVE COMMITTEE

1. The Executive Committee is composed of the President, *the Founding President* (*amended*) and four Vice-Presidents.

Art. 4 - THE CONGRESS

8. The Congress

e) Elects the four *Vice-Presidents (instead of members)* of the Executive Committee through general vote.
